**RECITALS**

**WHEREAS**, Invitee acknowledges that St. George has given permission to Invitee to enter the Premises during the dates and times set forth for the specific purposes set forth, and for no other purposes: and, **WHEREAS**, Invitee acknowledges that Invitee is paying a specified charge for the entry or use of the Premises: and,

**WHEREAS**, Invitee agrees to indemnify St. George from and against any claims made by Invitee or individuals associated with Invitee for injuries or damages sustained on the Premises.

**NOW THEREFORE**, for the considerations expressed above, Invitee and St. George agree as follows:

- A.** Invitee, and Invitee's members, invitees, customers, or any other party associated with Invitee, is granted permission to enter and use the recreational facilities only for the purposes set forth above, during the dates and times referenced.
- B.** Except for deliberate, willful, or malicious injury by acts or actions of St. George, St. George shall not assume responsibility nor shall St. George incur liability for any injury to any individual or property, including Invitee, Invitee's members, invitee's customers, or any other party associated with Invitee, while using the recreational facilities.
- C.** Except for deliberate, willful, or malicious injury by acts or actions of St. George, Invitee shall hold St. George harmless at all times from and against any "damages" that may be caused as a result of the entry or use of the recreational facilities by Invitee, or Invitee's members, invitees, Invitee's customers, or any other party associated with Invitee, while using the recreational facilities. "Damages," as used in this agreement, include any claims, actions, demands, losses, costs, expenses, liabilities (joint or several), penalties, and damages, including attorney's fees resulting to St. George from any injuries and damages to invitee, Invitee's members, invitees, Invitee's customers, or any other party associated with Invitee and third parties.
- D.** In further consideration of the use of the facilities and other good and valuable consideration, the sufficiency of which is acknowledged, Invitees do hereby on behalf themselves and of his/her child(ren) and for his/her heirs, executors, administrators and assigns, and on behalf of release acquit, and forever discharge St. George and any other persons, firms, and corporations of and from any and all actions, cause of action, claims, demands, damages, either direct or consequential, costs, loss of service, expenses or compensation, or whatever kind or nature that they may have by reason of participation in any and all events, and occasioned by participation in said events and use of the facilities..
